

PRIVACY POLICY January 1, 2020

This document details MV Pro Audio, Inc.'s policies regarding the collection, use, and disclosure of personal data when you use our Service (*i.e.*, Web sites operated by MV Pro Audio, Inc.), along with options you have regarding the use and handling of that data.

We use your data to provide sales and marketing services to you. By using our Service, you agree to the collection and use of information in accordance with this Privacy Policy.

Types of Data Collected

We collect several different types of information to facilitate communications and to provide and improve our Service to you.

Personal Data

While using our Service, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you ("Personal Data"). Personally identifiable information may include, but is not necessarily limited to, your email address, first and last name, phone number, address, cookies and Usage Data.

For the purpose of this Privacy Policy, MV Pro Audio, Inc. is the *Data Controller* of your Personal Data, that is, the legal person or entity who (either alone or jointly or in common with other people) determines the purposes for which and the manner in which any personal information is, or will be, processed.

We may use your Personal Data to contact you with newsletters, marketing or promotional materials and other information that may be of interest to you. You may opt out of receiving any, or all, of these communications from us by following the unsubscribe link or instructions provided in any email we send or by contacting us at info@mvproaudio.com.

Usage Data

We may also collect information that your browser sends whenever you visit our Service or when you access the Service by or through a mobile device ("Usage Data").

This Usage Data may include information such as your computer's Internet Protocol address (e.g. IP address), browser type, browser version, the pages of our Service that you visit, the time and date of your visit, the time spent on those pages, unique device identifiers and other diagnostic data.

When you access the Service by or through a mobile device, this Usage Data may include information such as the type of mobile device you use, your mobile device unique ID, the IP address of your mobile device, your mobile operating system, the type of mobile Internet browser you use, unique device identifiers and other diagnostic data.

Tracking Cookies Data

We use cookies and similar tracking technologies to track the activity on our Service and hold certain information.

Cookies are files with small amount of data which may include an anonymous unique identifier. Cookies are sent to your browser from a website and stored on your device. Tracking technologies also used are beacons, tags, and scripts to collect and track information and to improve and analyze our Service.

You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our Service.

Examples of cookies we use: Session cookies, Preference cookies, Security cookies.

Use of Data

MV Pro Audio, Inc. uses the collected data for various purposes, including to provide and maintain our Service, to notify you about changes to our Service, to allow you to participate in interactive features of our Service, to provide customer support, to gather analysis or valuable information so that we can improve our Service, to monitor the usage of our Service, to detect, prevent, and address technical issues, to provide you with news, special offers, and general information about other goods, services and events which we offer that are similar to those that you have already purchased or inquired about unless you have opted not to receive such information

Legal Basis for Processing Personal Data Under General Data Protection Regulation (GDPR)

If you are from the European Economic Area (EEA), MV Pro Audio, Inc.'s legal basis for collecting and using the personal information described in this Privacy Policy depends on the Personal Data we collect and the specific context in which we collect it.

MV Pro Audio, Inc. may process your Personal Data because we need to execute a contract with you; you have given us permission to do so; the processing is in our legitimate interests and it's not overridden by your rights; we need to processes payments; we need to comply with the law.

Retention of Data

MV Pro Audio, Inc. will retain your Personal Data only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.

MV Pro Audio, Inc. will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period of time, except when this data is used to strengthen the security or to improve the functionality of our Service, or we are legally obligated to retain this data for longer time periods.

Transfer of Data

Your information, including Personal Data, may be transferred to and be maintained on computers located outside of your state, province, country or other governmental jurisdiction where the data protection laws may differ from those in your jurisdiction.

If you are located outside United States and choose to provide information to us, please note that if and when we transfer data, including Personal Data, it is to Service Providers in the United States. Your acceptance of this Privacy Policy, as indicated by your acceptance of marketing and other communications from MV Pro Audio, Inc., represents your agreement to that transfer.

For the purposes of this Transfer of Data section and the MV Pro Audio, Inc., Privacy Policy in general, Service Provider shall mean a Data Processor, that is, any natural or legal person or entity who processes the data on behalf of the Data Controller (MV Pro Audio), such as Constant Contact, Reverb.com, PayPal, and the like.

We may use the services of various Service Providers in order to process your data more effectively and to provide more comprehensive services. MV Pro Audio, Inc. will take all reasonable steps necessary to ensure that your data is treated securely and in accordance with this Privacy Policy and no transfer of your Personal Data will be initiated unless there are adequate controls in place to safeguard the security of your data and other personal information.

Disclosure of Data

Disclosure for Law Enforcement

Under certain circumstances, MV Pro Audio, Inc. may be required to disclose your Personal Data when required to do so by law or in response to valid requests by public authorities (*e.g.* a court or government agency).

Legal Requirements

MV Pro Audio, Inc. may disclose your Personal Data in the good faith belief that such action is necessary to comply with a legal obligation, protect and defend the rights or property of MV Pro Audio, Inc., prevent or investigate possible wrongdoing in connection with the Service, protect the personal safety of users of the Service or the public, protect against legal liability

Security of Data

The security of your data is important to us, but please be aware that no method of transmission over the Internet or method of electronic storage is 100% secure. While we strive to use commercially acceptable means to protect your Personal Data, we cannot guarantee its absolute security.

Your Data Protection Rights Under General Data Protection Regulation (GDPR)

These third parties have access to your Personal Data only to perform these tasks on our behalf and are obligated not to disclose or use it for any other purpose.

Analytics
